MATCH FEES

\$70.00 per Team (Team consists of 5 designated shooters and 2 alternates)

\$10.00 per individual not firing on a designated team. (These shooters are eligible for individual awards.)

Payment must accompany entry form.

Match fees include lunch for paid team members and 1 coach per team. Individual match fees include lunch for the shooter only. We reserve the right to limit the number of Individuals to range capacity. Teams with Alternates have priority in relay assignment.

Any shooters with special needs requests should be brought to the attention of the Match Officials at the time of entry.

SCORING

Again this year we will require that all teams provide a scorer for each team (firing point). We will conduct scoring consistent with the procedure at past District Matches. There will be a 30 minute challenge period after the last targets are scored.

RULES

Current NRA and 4-H rules shall apply.

AWARDS

TEAM

1st, 2nd and 3rd place teams - team trophy and individual medallions

1st, 2nd and 3rd each position – trophy or medallion

High Individual with test – trophy or medallion.

All competitors that score 100 on the test will receive a certificate.

TEST

25 question, True/False test from the 4-H BB Rifle Safety Guide. Bonus/Tie Breaker questions will be from NRA BB Gun Rules.

DIRECTIONS

To The Coweta County Fairgrounds & Conference Center

1) From Atlanta: Take I-85 South to Exit 41 (Moreland/Highway 29) and take a right off the ramp. Go past Waffle House to the first road on the left, Pine Road. Take Pine Road for approximately one-half mile over the railroad tracks. The entrance to the facility is on the left.

2) From Columbus: Take I-85 North to Exit 41 (Moreland/Highway 29) and take a left off the ramp. Go past Waffle House to the first road on the left, Pine Road. Take Pine Road for approximately one-half mile over the railroad tracks. The entrance to the facility is on the left.

3) From Downtown Newnan: Take LaGrange Street from the court square and follow signage to Highway 16/29 South (Greenville Street). Go approximately two miles to Corinth Road and take a right (at the Georgia Power Office). Turn left on Pine Road to Fairgrounds. Entrance will be on your right.

4) From Carrollton: Take Highway 16 into Newnan to Jackson Street. Go right on Jackson Street to the Court Square through three traffic lights and that turns into LaGrange Street. Take LaGrange Street from the town square and follow signage for Highway 16/29 South (Greenville Street). Go approximately two miles to Corinth Road and take a right (at the Georgia Power Office). Turn left on Pine Road to Fairgrounds. Entrance will be on your right.

5) From Peachtree City/Fayetteville: Take Highway 54 through Peachtree City to Coweta County. Stay on Highway 54 at the 54/34 split. Go approximately seven miles to the four-way stop at Highway 16. Go right on Highway 16 for approximately nine miles until it joins US Highway 29. Go right and then take a quick left onto Pine Road. Go one-half mile over the railroad tracks and the entrance to the facility is on the left.
