POSITION # OF SHOTS TIME LIMIT

Prone	10 shots**	10 minutes
Standing	10 shots**	10 minutes
Sitting	10 shots**	10 minutes
Kneeling	10 shots**	10 minutes

** Unlimited sighting shots may be fired in all positions provided all sighting and record shots are fired during time limits.

MATCH FEES

\$75.00 per Team (Team consists of 5 designated shooters and 2 alternates)

\$15.00 per individual not firing on a designated team. (These shooters will compete in the Alternate Match.)

Match fees cover cost of targets and awards. We reserve the right to limit the number of Individuals to range capacity. Teams with Alternates have priority in relay assignment.

Any shooters with special needs requests should be brought to the attention of the Match Officials at the time of entry.

ELIGIBLE TEAM MEMBERS

Team members must be eligible to compete in the 2012 Daisy NBBGC in order to compete on the team. A shooter who competed at the 2011 Daisy NBBGC as a regular team member may only compete in the Alternate Match and their scores may not be used for team awards and qualification.

SCORING

We will require that all teams provide a scorer for each team (firing point). We will conduct scoring consistent with the procedure at the Daisy National BB Gun Championship. Scores will be final as of posting. This will speed up the post-match tabulations and the awards ceremony.

RULES

Current NRA rules shall apply.

AWARDS TEAM

1st, 2nd, and 3rd place teams – team trophy and individual medallions

1st, 2nd, & 3rd each position – medallions

All competitors who score 100 on the test will receive a certificate.

ALTERNATES

1st, 2nd, & 3rd each position – medallions

All competitors who score 100 on the test will receive a certificate.

TEST

50 question true / false test from the Daisy Ten Lesson Curriculum and NRA BB Gun Rules.

DIRECTIONS

To the Indian Creek Elementary School Gymnasium

1) From West of Douglas: Take GA Hwy. 32 east to GA Hwy. 206 (first traffic light). Turn right on GA Hwy. 206. Go approximately 1 mile to GA Hwy. 158 (second traffic light). Turn right. Go approximately 6/10 mile. Indian Creek School drive/sign will be on the left.

2) From East of Douglas: Take GA Hwy. 32 west to GA Hwy. 206 (first traffic light past hospital). Turn left on GA Hwy. 206. Go approximately 1 mile to GA Hwy. 158 (second traffic light). Turn right. Go approximately 6/10 mile. Indian Creek School drive/sign will be on the left.

3) From North of Douglas: Take US Hwy. 441 South to GA Hwy. 158 (first light past the railroad crossing in town). Turn right on GA Hwy. 158. Go approximately 2.1 miles. Indian Creek School drive/sign will be on the left.

4) From South of Douglas: Take US Hwy. 441 North to GA Hwy. 206 (first traffic light). Turn left on GA Hwy. 206. Go approximately 2 miles to GA Hwy. 158 (third traffic light). Turn left. Go approximately 6/10 mile. Indian Creek School drive/sign will be on the left.
