Scoring: all teams must provide at least one scorer for the match

Challenges: A scoring challenge fee of \$1.00 per individual target. Circle the target number associated with each individual target to be challenged.

Awards: 1st, 2nd, and 3rd place teams- team trophy and individual trophy
1st, 2nd, and 3rd place for each position – individual trophy
High individual total score - trophy

Range: The City of Cumming Fairgrounds is inside a livestock barn. There is very limited space for team areas in the barn. We have plenty of room outside in the parking area. Please bring chairs.

Targets: AR4/10 targets will be provided. Competitors must bring all other necessary equipment, target boxes included.

Requirements: Each team must supply an adult coach on the firing line and an adult leader to help with scoring.

Concessions: Biscuits for breakfast . Hamburgers, hot dogs, nachos, candy, drinks and deserts. Parking is below the red barn. There will be someone directing traffic in the parking lot.
